## 2. Conditions of use

## 5. Cookies policy

The entity: AGRÍCOLA SON JULIÀ, S.L. expressly informs that, in accordance with article 22.2 of Law 34/2002, of July 11, on services of the information society and electronic commerce (LSSI), the website [www.sonjulia.com](http://www.sonjulia.com) uses 'cookies' own and third party to offer you a better experience and service. By browsing or using our services, the user expressly accepts the use we make of 'cookies'.
